REMINDER: Centralized Processing of Returned BNC Mail

On October 15, 2012, the Judiciary's Bankruptcy Noticing Center (BNC) contractor began accepting, processing and securely disposing of notices that would otherwise be returned to the bankruptcy courts by the United States Postal Service (USPS).

Under the terms of the established contract, the BNC contractor has two business days from receipt to process the returned mail and autogenerate a Notice of Returned Mail e-mail notification to the debtor's attorney, with a copy of the notice as a PDF attachment, advising the returned mail by the USPS. If no attorney e-mail address is available or if the debtor is pro se, the Notice of Returned Mail will be sent by U.S. mail to the attorney or pro se debtor, as appropriate.

Debtor's attorney will receive returned mail in bankruptcy cases either by regular USPS mail for those items where the return address is the debtor's attorney, and e-mail Notices of Returned Mail for mail that would have been sent back to the bankruptcy court.

Upon receiving the Returned Mail Notice to Debtor/Debtor's Attorney (see attached), the Debtor's attorney may use the form to provide an updated address for the Notice Recipient to the BNC to ensure proper noticing in pending bankruptcy cases.
