Bankruptcy Court Miscellaneous Fee Increase Effective November 1, 2011 and Electronic Public Access Fee Increase Effective April 1, 2012

The Judicial Conference of the United States, at its September 2011 session, approved increases to the Bankruptcy Court Miscellaneous Fee Schedule which will become effective November 1, 2011.

A complete list of the changes is attached to this announcement.

In addition, the Judicial Conference of the United States amended the Electronic Public Access Fee Schedule.

Effective April 1, 2012, the fee for electronic public access to court records through the PACER system will increase from \$.08 to \$.10 per page. To lessen the impact of the increase, the quarterly exemption will be raised from \$10 to \$15. Implementation of the fee increase for local, state, and federal government agencies will be suspended for three years.
