

## Chapter 7 Trustee's Report of No Distribution

Section 602 of the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005 (BAPCPA), as codified in 28 U.S.C. §589b, requires uniform final reports for bankruptcy cases. The UST Form 101-7 No Distribution Report (NDR) requires specific data elements regarding each chapter 7 no asset case and has variable text depending upon the situation the trustee determines for that case.

Four NDRs are a virtual (text only) entry. Two NDR (Adhoc) entries allow PDF attachment and are not virtual (text only) entries.

- ◆ The text in each event varies depending upon whether any funds were collected, or if the case has been converted, dismissed or reassigned to another trustee.

- ◆ Most of the NDR entries are accessible through the **Trustee's 341 Filings** category where multiple NDRs can be filed, or through the **Trustee/US Trustee** category where individual NDRs can be filed in individual cases.

**NOTE:** A case appears in the **Trustee's 341 Filings** category only if the §341 Meeting has not been terminated in ECF. Many cases will convert or be dismissed after the §341 Meeting has been held and terminated and will no longer appear on the list of cases for that trustee. Single case docketing will be required in those instances.

- ◆ Data elements required for this report are:
  - gathered from values in the debtor's schedules in the database at the time the report is produced,
  - calculated from database values on the case, and
  - entered by the trustee following the §341 meeting.
- ◆ If values from the debtor's schedules do not apply to the report selected, text will display these values as "Not Applicable".
- ◆ If values from the debtor's schedules have not been submitted at the time the **No Funds** or **Minimal Funds** reports are filed, text will display "Not Available".

## Accessing Trustee's 341 Filings Program

- ◆ Access the program through **Bankruptcy/Trustee's 341 Filings**.
- ◆ Enter the date of the 341 meeting in the "Date" field.
- ◆ A total of eight (8) columns will display (See Figure 1):
  - Case Number
  - No Action
  - Report of No Distribution-No Funds
  - Report of No Distribution-Dismiss/Convert No Funds
  - Report of No Distribution-Dismiss/Convert Funds
  - Report of No Distribution-Min Funds
  - Meeting Held
  - Continue To

## Chapter 7 Trustee's Report of No Distribution No Funds

### Trustee's 341 Filings

- ◆ Selecting the **No Funds** radio button will expand to display the fields used to produce the report (See Figure 2).

- ◆ The following data field values will not be greyed out and are accessible by the trustee for entry or modification as necessary:
  - Assets Exempt (6C)
  - Assets Abandoned
  - Claims Discharged
  - Claims Scheduled
- ◆ Additional docket text can also be added to this entry, which will display on the docket. The option to select "Appeared" or "Absent" may also be chosen. The default is set to "No Text".
- ◆ See page 6 for information common to both types of entry processes.

- ◆ Filing **Chapter 7 Trustee's Report of No Distribution - No Funds** in a single case will present the screen below (See Figure 3).

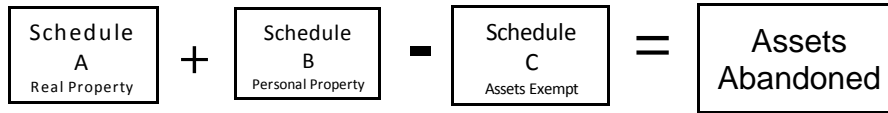

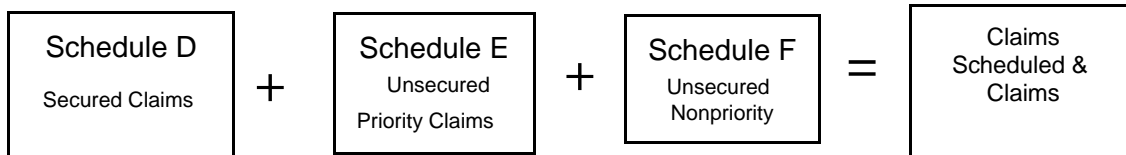

**Information common in both entry processes:**

- ◆ For both entry processes, the values in Schedule A + Schedule B - Schedule C = the value in the Assets Abandoned field.



- ◆ The values for Assets Abandoned and Assets Exempt remain accessible in the event the trustee needs to enter an amount that does not equal A + B - C. If the trustee enters an amount in either of these fields, the remaining values on the screen will not be recalculated or automatically adjusted.
- ◆ The values in Schedule D + Schedule E + Schedule F = total reported for Claims Discharged and Claims Scheduled.



- ◆ The Claims Discharged and Claims Scheduled values remain accessible in the event the trustee needs to enter an amount that does not equal D + E + F. If the trustee enters an amount for either of these values, the remaining values on the screen will not be recalculated or automatically adjusted.

- ◆ The number of months pending will be calculated from today's date less the file date of the case.
- ◆ If values from the debtor's schedules do not apply to this report, text will display these values as "Not Applicable". Otherwise, if the debtor's schedules have not been submitted when the **NDR - No Funds** is filed, text will display "Not Available".
- ◆ Final Docket Text will appear as shown below (See Figure 4).

## Chapter 7 Trustee's Report of No Distribution Dismissed or Converted, No Funds

### Trustee's 341 Filings

- ◆ When a case has either been dismissed, converted or reassigned, and no funds are available for distribution, no additional entry of data is required in the Trustee's 341 Filings program.
- ◆ When the **Dismiss/Convert No Funds** radio button is selected, as shown below, the row will expand only to offer the **Additional docket text** box and the option to select "Appeared" or "Absent". The default is set to "No Text". (See Figure 5).

## Chapter 7 Trustee's Report of No Distribution Dismissed or Converted, Some Funds Collected



